- Please note all State of Israel Bonds are issued in book entry only and will be sent directly to the registered owner(s).
- **Please note: if you are reinvesting or redeeming bond(s) that are jointly owned by two or more people, all registered owners must complete and sign the enclosed authorization form.**

- All payments should be made payable directly to **State of Israel**.
- Please remit payment along with completed forms to your local Israel Bonds office, contact information below.
- For reinvestment payments using matured bond certificates, please include the bond certificates along with your investment form.
