A message from Rabbi Philip Scheim National Rabbinic Chair, State of Israel Bonds Canada

Dear Friends of Israel,

This summer we have all felt the anxiety of events in Israel, whether close at hand during time spent in Israel, or whether from a distance, with our attention riveted to the insidious Hamas rocket attacks on Israel's civilian population and the necessary and just Tzuk Eitan (Protective Edge) operation to restore quiet to Israel.

We have been disquieted by the unsurprising and yet troubling resurgence of anti-Semitism throughout the world, and the inability or refusal for most of the world's media to see through the Hamas/Palestinian spin on what has transpired.

In light of these continuing challenging times, and in recognition of the courageous response of Israel's leaders, of Zahal; Israel's moral and determined armed forces, and of Israel's civilian population, and in tribute to our heroic fallen and injured soldiers, our annual State of Israel Bonds High Holiday Campaign takes on added significance this year.

Conducting the campaign

1. Distribute Tab Cards.

The tab cards must get into the hands of the members of the congregation. We encourage you to review previous appeals and develop the most efficient plan and methods.

Don't have a plan or want to upgrade? Contact Marcia Cantor.

2. Collect Tab Cards.

Your Israel Bonds representative will provide the congregation with collection boxes (Also known as "Ballot Boxes").

At the conclusion of the appeal, schedule a few minutes for members of the appeal committee and other volunteers to walk slowly up and down the aisles of the sanctuary, holding collection boxes for members to insert their cards. Following the brief collection period, a few boxes should be placed in conspicuous locations in the synagogue – and their locations announced – for residual card drop-off.

3. Choose Your Israel Bonds Speaker.

The most effective appeal-giver is a person who can speak passionately and personally about Israel; someone whose personal experiences with Israel and Israel Bonds can help synagogue members connect with their primary and most meaningful Israel experiences.

4. Timing of the Appeal.

Your success is directly related to the number of seats occupied at the time of the appeal. It is recommended you conduct your appeal the first day of Rosh Hashanah (before noon), Kol Nidre (before the Rabbi speaks), or Yom Kippur (before Yizkor).

5. Before/After.

Pre-appeal events can boost the results of the appeal, as will bulletin articles, bimah announcements, and other reminders. Israel Bonds also has a full complement of digital marketing items available for your online bulletin and weekly communications, as well as email advertising, linking readers directly to www.israelbonds.ca

Important ways the Rabbi can enhance a High Holy Day campaign

- 1** Recommend an exceptional, i.e. dependable, creative, outgoing, energetic, congregational Israel Bonds chairperson.
- 2** Make sure congregational leadership knows you desire a successful campaign and encourage Members of the Board to demonstrate leadership by making an indication to invest – announce % of board participation during the campaign.
- 3** Schedule the campaign at a time during services when the seats are filled.
- 4** Speak to your congregation about your love for Israel and personal support for Israel Bonds and set a 20% percent goal of increasing the number of members joining the campaign this year. Remind congregants that in many cases, Israel Bonds purchased in previous High Holy Day campaigns are about to mature. This represents an easy opportunity to reinvest these bonds and help each Synagogue stand proudly as a great supporter of Israel through Israel Bonds.
- 5** Distribute Israel Bonds High Holy Day email/ad to your member email list.
- 6** Tweet to your followers your support for Israel Bonds. Include Israel Bonds URL: www.israelbonds.ca on your Facebook wall.

- 7** Announce the upcoming campaign during Shabbat services, congregational events and in congregational publications. Continue with follow-up announcements in the weeks after the appeal.
- 8** Include Israel Bonds link on your congregation's website.
- 9** Contact your local Israel Bonds office about creating a pre-High Holy Day campaign event to encourage investments and announce the sum and number of those investments during the Israel Bonds speech.
- 10** Mail "if you didn't participate you still can" follow-up letter or email provided by Israel Bonds.
- 11** Invite Israel Bonds to sponsor an Oneg/Kiddush and speak to the congregation on Shabbat a few weeks prior to the campaign.

Talking points

Each item below can be used as a starting point for composing remarks, be inserted whole or part into remarks, or as stand-alone comments.

For many years, at this time of the year, someone who cares passionately about the State of Israel has stood in their synagogue and made a plea for all those assembled to invest in Israel Bonds.

Let us be clear on what is being asked:

We are asking people to adjust their investment portfolios to include Israel Bonds as a larger part of the total. The call to invest in Israel Bonds is a call to invest in our values, to invest in our people, to invest in the only Jewish State in the world.

WHY INVEST IN ISRAEL BONDS AT THIS TIME OF THE YEAR?

IT IS OUR PRIVILEGE AND OUR DUTY TO ENGAGE IN THE MITZVAH OF "BINYAN HA'ARETZ."

"Binyan Ha'aretz" – the ongoing building of the Land of Israel.

The first Chief Rabbi of the State of Israel, Rabbi Herzog, wrote in 1951 that the act of investing in Israel Bonds during the most Holy Days of the Jewish year is part of the fulfillment of the mitzvah of building the Land of Israel!"

The first Sephardic Chief Rabbi, Rabbi Oziel, stated that it is a mitzvah to purchase Israel Bonds on Rosh Hashanah and Yom Kippur in order to fulfill the commandment of settling in Israel.

Many Rabbis from all denominations, over the years, have echoed these thoughts.

We are all concerned that the High Holy Day services be meaningful, focused, spiritual, and Holy. As such, some have voiced concern about having an Israel Bonds focus on Yom Kippur evening at Kol Nidray, or in the morning prior to Yizkor.

Rabbi Reuven Bulka has written that it is most appropriate to focus on Israel during Yom Kippur, and on what Israel means to us individually and collectively; and how much our connectedness to Israel enhances our Jewishness. Israel Bonds affords us the opportunity to partner with Israel, to help Israel, and to provide safe haven for Jews from everywhere.

On Yom Kippur, he stated, when we are called to Holy action, there can hardly be a more sacred expression than to actively express our love of Israel and support of it, even if it be via the mention of investments. By investing in Israel, we sanctify that money, ennobling what otherwise would be mundane.

To spend Yom Kippur praying is obviously necessary, but not sufficient. Authentic prayer must lead to meaningful action. This is a most potent combination, which Israel Bonds affords us the opportunity to actualize.

Far from being a compromise of High Holy Day decorum, he concluded, having an Israel Bonds focus is precisely what we need on Yom Kippur or Rosh Hashanah.

"To be a free people, in our own land" has long been our hope. Every Jew has a right to emigrate to Israel, to live in Israel and to visit Israel for lengthy periods of time. Israel is our home. All homes require ongoing investments.
