



**Instructions for Redeeming Certain Israel Bonds in Israel**

Certain series of Israel bonds can be redeemed **in Israel**. (The Appendix at the end of this document lists those bonds that can be redeemed in Israel). The State of Israel has made provisions for redemption with the Bank of Israel in Jerusalem.

If you would prefer to redeem your bond(s) **outside of Israel**, contact your Israel Bonds representative or the State of Israel’s Fiscal Agent, Computershare, using the contact information noted below:

**You can redeem your bond at any time by sending the certificate for redemption to Computershare, the State of Israel’s fiscal agent, at Computershare, 150 Royall Street, Canton, MA 02021, telephone +1 (866) 764-3425 (US bondholders) or Computershare, 1500 Robert-Bourassa Boulevard, Montreal, Quebec H3A 3S8 (bondholders outside the US).**

**Redemption through the Bank of Israel**

For bonds that have not yet reached final maturity, there is a limit on the amount that can be redeemed in Israel – up to \$1,000 per year for an Israeli resident, and up to \$2,500 per month for a nonresident. There is no limit for bonds that have reached final maturity.

In a case where the bondholder is deceased or the bond was transferred by the original bondholder to a third party, please contact Computershare directly to redeem the bond(s).

**Redemption in Israel:**

Only bondholders who have a bank account in Israel or who wish to redeem the bond for cash payment at the offices of the Bank of Israel in Jerusalem (at a pre-scheduled meeting) may redeem the bond through the Bank of Israel.

**Please note that such redemption may be subject to tax withholding, as further explained below.**

**A. The process**

**The process for redeeming bonds through the Bank of Israel is as follows:**

1. Mail the original bond certificate, the Redemption Information Form found at the end of these instructions, and the supporting documents to the appropriate Israel Bonds office at the address(es) below. We require this information so that the Israel Bonds organization and the Bank of Israel can verify that you or the entity that you represent are the rightful owner of the bond and for tax reporting purposes. We recommend that you retain a copy of all documents for your records, and that you send the certificate(s) using a method that allows you to track the package.

2. Decide whether you want to receive the redemption funds by bank transfer to a bank account in Israel or at the cashier's desk at the Bank of Israel in Jerusalem in cash and mark the relevant box on the form.
3. Once your redemption request is reviewed by the Israel Bonds office, if the documentation is in order, Israel Bonds will provide you with a voucher that you must present to redeem the bond at the Bank of Israel cashier's desk for cash payment. If you elect payment by bank transfer, you will receive a voucher from Israel Bonds that you must sign and return to Israel Bonds but do not need to schedule a meeting in Israel. The Bank of Israel is the only entity that will accept the voucher. The voucher will be valid for redemption **ONLY** by the person(s) or entity listed on it, who must provide the government-issued original identity document(s) listed on the voucher to the Bank of Israel, along with the additional documents listed in the chart below. The voucher will specify the interest amount on the principal amount of the bond. The Bank of Israel will withhold the required tax from the interest amount.
4. Please note that once your redemption request is reviewed and you receive a voucher, you will **not** receive your original certificate back. You will be able to redeem the bond only in Israel with the voucher provided if you selected cash payment or by bank transfer to the Israeli bank account you listed on the Form. **You will have one year from issuance of the voucher to redeem it in Israel by cash.**
5. If the voucher expired or it has been lost, contact the Israel Bonds office for assistance.

More Information about Payment Options:

a. Payment via bank transfer to an account in Israel - the sum to be transferred, after the required tax deduction, if any, will be made in Israeli shekels (ILS). The Israel Bonds office will send your signed voucher and the related documents to the Bank of Israel to make the bank transfer and will send a copy of the voucher to you for your records, Note that for a bank transfer, the transfer will be made after the required tax deduction, if any. **If you do not pay taxes in Israel, complete the Foreign Resident Tax Form (which requires that your signature be notarized) and provide that document to the Israel Bonds office.**

b. Payment via cash - You will receive your payment in Israeli shekels (ILS) at the representative exchange rate in effect on the day you are paid. **You must present the voucher and all the required documents in person at the Bank of Israel at 2 Kaplan Street, Jerusalem, Israel. Do not sign the voucher until you are at your appointment at the Bank of Israel. You will need to set up an in-person meeting in advance, by email, by contacting [milvot@boi.org.il](mailto:milvot@boi.org.il) so that you will be admitted to the building when you arrive. The process can take some time, so please plan accordingly. There is no guarantee you will be able to meet with an English-speaking**



clerk. The payment will be made after the required tax deduction, if any. **If you do not pay taxes in Israel, complete the Foreign Resident Tax Form (which requires that your signature be notarized) well in advance of your trip to Israel and provide that document to the Israel Bonds office for forwarding to the Bank of Israel**

**B. Tax Consequences for Israeli Residents and non-residents:**

The redemption may be subject to withholding tax in Israel. A foreign resident will complete a statement attached to this form, affirming that they are a foreign resident. The tax will be withheld, if so required, by the Bank of Israel. The rate of withholding tax, if any, is as provided in the table below, or will be set in accordance with Israeli tax law that will apply at the time of the withholding.

**C. Documents required for payment -**

Please provide the bond certificate, identity related documentation listed on the Form below and the applicable tax documents required by the Bank of Israel to the Israel Bonds office. Israel Bonds will review and verify the identity of the bondholder and the status of the bond. The Bank of Israel will review the tax forms provided and will inform Israel Bonds if additional tax information is needed from the bondholder. If you are a non-resident of Israel and have questions about the tax documentation, please contact Israel Bonds and Israel Bonds will verify with Bank of Israel what information is required from you. Your voucher will not be issued until Israel Bonds has verified your identity and the status of your bond. **Maximum Tax withholding will be made if the Bank of Israel determines that the tax documentation provided is not sufficient.**

Bring copies of all the documentation you provided to Israel Bonds, copies of your tax documents and your original identity document to the appointment at Bank of Israel.

I further affirm that I have not transferred or assigned the bond to any other party and that I plan to redeem it through the Bank of Israel by bank transfer or by cash. I understand that the State of Israel, Bank of Israel and Development Corporation for Israel/Israel Bonds, Canada-Israel Securities, Limited and Development Company for Israel (Services) Ltd cannot provide tax advice to me and I must contact an accountant or other tax advisor for inquiries relating to the tax consequences of redeeming the bond(s). I further understand that I am responsible for all tax reporting requirements relating to the bonds, waive, and disclaim any liability against the State of Israel, Bank of Israel or the Israel Bonds entities listed above relating to such tax reporting.
